2022 TELECOMMUNICATIONS WORKSHOP

This workshop is required of all operators and owners of Auxiliary Radio Facilities. It is required of those currently holding a Telecommunications Operator (TCO) qualification or in training for TCO qualification, and those who are using AUXCOM as their "grandfathered" qualification for radio operation. This does not apply to operation of radios on aircraft or vessels which are covered by crew certification.
